LIMITED WEAR & STRUCTURE WARRANTY

Limited Wear & Structure Warranty

GROUND LEVEL SPC Limited Wear and Structure Warranty

GROUND LEVEL FLOORING warrants the SPC series products to be free from manufacturing defects for a specified length of time from the date of purchase as set forth below. 20 mil products have a 20-year limited residential warranty and a 10-year light commercial warranty. 12 mil products have a 10-year limited residential warranty and are not warranted for commercial use. The wear layer of the floor plank is warranted by GROUND LEVEL not to wear through under normal use for the length of the warranty. Gloss reduction, dents, or surface scratches are not considered surface wear. The structure of the plank is warranted by GROUND LEVEL not to warp, crack, or delaminate. This warranty is nontransferable and applies only to the original purchaser.

How to Obtain Warranty Service

The warranty holder must inspect the flooring for manufacturing defects caused by improper milling, grading, staining, and coating, and report such defects to GROUND LEVEL, prior to installation of the flooring. Warranty holder must provide documentation of sales order and proof that the flooring was properly installed in accordance with the installation guide.

Warranty Scope

If a valid warranty claim is received by GROUND LEVEL FLOOR within the applicable Warranty Period, GROUND LEVEL FLOOR will supply new materials of similar grade for repair or replacement of affected areas. Labor costs, including any expenses associated with installation and removal of defective flooring, are not covered by this limited warranty. To the extent permitted by law, these are the sole and exclusive remedies of the Warranty Holder in the event of a manufacturing defect or other warranty claim.

This limited residential wear warranty is made subject to the following conditions:

- The floor must be installed properly and according to GROUND LEVEL SPC installation guidelines.
- The flooring must be used only indoors in a dry, climate-controlled area.
- The flooring must be maintained in accordance with GROUND LEVEL SPC maintenance guidelines.
- This limited warranty does not apply to damage caused by water or moisture in the subfloor or underneath the flooring, including but not limited to damage from subfloor hydrostatic pressure or other conditions that result in water or moisture being under the floor. It does cover topical moisture. If the water does not flow over the edge of the surface (edge of the room, cut boards, etc.) water will evaporate before passing between the planks to the subfloor or damage the planks.

Limited Wear & Structure Warranty

What the “wear and structure” warranty does not cover:

- Damage due to adhesives or tape, scratches, gouges, scuffs, punctures, cuts, indentations, burns, accidents, lack of proper furniture rests or any intentional misuse of the product. Loss of finish gloss over time is consistent with normal wear and tear and is not a product flaw.
- Problems due to moisture (except for topical spills as noted above), mildew, alkaline substances, hydrostatic pressure, expansion and contraction between planks/tiles or humidity levels above or below those recommended.
- It is normal and expected for there to be color variations due to use of natural components, exposure to UV light and/or sunlight, and age of material. Therefore, color inconsistency between samples, replacement product or illustrations and actual product is not a manufacturing defect.
- Inherent variations that are consistent with those of a natural product to include pattern, color, and texture do not indicate defective material.
- Noncompliance with installation guidelines and maintenance guidelines as recommended by GROUND LEVEL.
- GROUND LEVEL cannot assume responsibility for the suitability of flooring material and accompanying products for each individual installation as manufacturer has no control over the installer’s proper application.

- Cracking, warping, soiling, fading, improper maintenance or abuse caused by items such as roller skates, cleats, golf shoes or pets.
- Floor covering installed in inappropriate locations is excluded from this warranty. Some states do not allow the exclusion or limitation of incidental or consequential damages so that the above limitation and exclusion may not apply. Your warranty gives you specific legal rights, and you may have other legal rights, which vary, from state to state. This warranty is in lieu of any other warranties, expressed or implied. Please keep your receipt. GROUND LEVEL requires the receipt to verify date of purchase to help resolve any problems.

Warranty Owner

This Warranty applies only to a resident home or business owner who is the original purchaser of the GROUND LEVEL SPC floor products, not to any subsequent owner. This warranty shall not include loss of time, inconvenience, incidental expenses (such as telephone calls, labor and/or materials) incurred in the removal or reinstallation of the affected material, and any other incidental or consequential damages.
